ORDER

NO.SO (G)/P&SHD/4-1/2020. In exercise of powers under Sections 4(c), 5(1)(e), 5(1)(f) of "The Punjab Infectious Diseases (Prevention and Control) Ordinance 2020", I, Captain (R) Muhammad Usman, Secretary, Primary and Secondary Healthcare Department, Government of the Punjab, with the approval of Chief Minister, Punjab, do hereby order as follows:

- a. All Educational and training institutes, Marriage halls, Business centers, Expo Halls, Restaurants (except takeaway & home delivery), Theme/ amusement parks, public parks, Play Areas and arcades, Beauty Parlors and Spas, Cinemas, Theaters shall remain closed.
- b. There shall be a complete ban on Sporting tournaments/ matches (indoor and outdoor) except non-contact professional sports without spectators. All contact sports & indoor sports clubs/facilities shall remain closed.
- c. There shall also be a complete ban on gatherings of all kinds for social, religious, or any other purpose at any place, public or private.
- d. All retail shops, markets, Shopping malls and Plazas shall remain closed except the following, which shall remain open: -

S. No.	Particulars	Time
a.	All medical services & Pharmacies/ Medical Stores, Tire puncture shops, atta chakkies, postal/courier services, driver hotels, petrol pumps, oil depots, LPG outlets & filling plants, agriculture machinery workshops and spare parts shops, printing press, call centers (with 50% staff and no public dealing), Takeaway/Home Delivery from restaurants	(24 hours a day)



b.	Grocery Stores, Bakeries & Karyana Stores, fruit & vegetable shops, chicken, meat and milk shops, tandoors.	(6AM to 12AM)
c.	Inter-city & Inter-district public transport	(24 hours a day)

- 2. This order shall remain in force in the entire Province of Punjab with effect from Monday midnight, 12:00 AM 28.07.2020 till 12:00 AM Wednesday midnight, 05.08.2020 unless modified otherwise.
- 4. This order shall be given wider publicity in official Gazette, Daily Newspapers and broadcasting through Radio Pakistan, Pakistan Television and other TV Channels as news item for information of the general public.
